Outcome 1: A learner wellbeing and safety system	Students benefit from a physically safe and supportive learning environment that responds to the needs of every student.	CTC provides this through a safe campus, interactive teaching through onsite and distance and learning that aims to demonstrate best practice. Evidence of this is in Health and Safety documents, policies on our website, information in the Blackboard SMS (for level 7 students), information in Canvas SMS (for level 5 and 6 students) and the student course reviews at all levels. We gathered evidence from the students' perspective through student (with 76% of students that feel well supported by their Pastoral Care representative) and staff pastoral code surveys (63% of our respondents rate our Pastoral Care Support well). A recent post-study outcome survey showed 87% of our students rated their well-being at 4 or above on a 5-point scale.
Outcome 2: Learner voice	CTC fosters this through interactive teaching and learning, along with avenues to express their voices (Student representation in Board of Studies, Library Committee, Academic Advisory Board). Evidence is in our policies and minutes.	The voice of our students is upheld in their learning environment showing they are heard and integrated in decisions around the planning and provision of student support services. We have gathered evidence from the students' perspective from student's course evaluations, pastoral care surveys, orientation surveys, graduate surveys, and a post-study outcome survey.

#### Outcome 3: Safe, inclusive, supportive, and accessible physical and digital learning environments

CTC supports students in managing their physical and mental health through its various support systems, ensuring they can access help whenever needed.

CTC provides this through advice during enrolment through the Registrar and Enrolment Committee (for level 7 students). The Librarian is also able to provide all students access to its well-resourced 'Colin Library' with over 60,000 print volumes, 10,000 eBooks, and 850 ejournals available. CTC offers timely information about assessment and progression, and in response to any stated or observed needs, and information during Orientation week and in email, newsletter and arranged meetings both informal, including social and formal. Evidence of this is the enrolment form itself, advice students get, Orientation presentation and email correspondence. Also provides this through realistic timelines, opportunities for students to submit late and/or resubmit work (upon request) to better met the students need and that of their workplace (when relevant). Help and information is available in Blackboard SMS for level 7 students and Canvas SMS for level 5 and 6 students. Resources and facilities of Te Kupenga incorporate partnerships with Māori educators (running special initiatives this year) and relevant professional development for staff is integrated into staff training opportunities as per the updated Te-Tiriti-o-Waitangi-and-Bicultural-Relationships-policy document and the most recent Workstream on Te Reo and Tikanga Māori. Evidence is gathered from the students' perspective through student pastoral code surveys and evaluations. When students have suggested improvements, these are acted on to help students more effectively in their student journey.
